A. NON-CONFIDENTIAL FACTS AND ADVICE TO THE PCC

A1. INTRODUCTION AND BACKGROUND

- 1.1 The Police and Crime Commissioner ("the PCC") has made clear his plan for crime and policing in Lincolnshire through the Police and Crime Plan. To support this plan the Chief Constable has developed the Operational Policing Delivery Plan, setting out what the Force will do to achieve the Commissioners stated objectives.
- 1.2 In order to deliver the plan, the Force requires an appropriate level of police officers. Analysis carried out by the Force based on demand for policing services in Lincolnshire indicates that a level of 1100 warranted police officers is critical to delivering the required level of service in the county. The PCC supports this level of establishment.
- 1.3 To ensure the establishment is maintained at the level required by the Commissioner there is a need to bring forward recruitment from 2013/14 into the current financial year. The Force is therefore seeking to recruit 23 student officers in March 2013, 14 of which have already been identified from the pool of previously approved applicants.

A2. LINKS TO POLICE AND CRIME PLAN AND PCC'S STRATEGIES/PRIORITIES

2.1 This early recruitment will maintain the agreed establishment of 1100 officers in 2013/14, thus ensuring that the Force has sufficient resources to deliver on the priorities and objectives contained within the Police and Crime Plan.

B. FINANCIAL CONSIDERATIONS

The proposed budget for 2013/14 and 2014/15 include provision for 1100 officers.

C. LEGAL AND HUMAN RIGHTS CONSIDERATIONS
