A1. INTRODUCTION AND BACKGROUND

- 1. The Police and Crime Commissioner recognises the role that the voluntary and community sector, communities and individuals can have in preventing crime and making the places where they live and work safe.
- 2. The Commissioner has made resources available through a Community and Volunteer Fund http://www.lincolnshire-pcc.gov.uk/Get-Involved/Community-and-Volunteer-Fund.aspx to assist small local, community based groups in reducing crime and anti-social behaviour and supporting the victims of crime. In particular, the Commissioner would like the Fund to support as many smaller projects as possible, projects which are aimed at younger and older members of the community and which are supporting victims, witnesses and vulnerable people.
- A Fund has been established for 2014-2015 with grants awarded for projects and initiatives that contribute to the Commissioner's priorities as set out in his Police and Crime Plan 2013-2017 (http://www.lincolnshire-pcc.gov.uk/Document-

- Six further applications have successfully met the funding criteria since the Fund 4. was launched. These are detailed at Appendix A.
