# **EXECUTIVE SUMMARY AND PURPOSE OF REPORT**

The original EMSOU CT Agreement was signed regionally in May 2012. Since then, the collaborative working arrangements have continued to mature and are now very well embedded within EMSOU and the five constituent forces. The main substance of the original Agreement has served the region very well and therefore remains unchanged.

It was however always the intention that a number of the more complex aspects of the collaborative arrangements would be reviewed and subsequently incorporated within a revised Agreement hence the production of an updated Section 22a EMSOU SB collaboration. This Agreement strengthens the region's position with respect to the primacy issues associated with the ongoing discussions around the national CT collaboration agreement.

- 1. This is a request to renew an existing collaboration agreement in respect of the across border authorisation of RIPA requests.
- 2. For the purposes of the Police Act and RIPA, this is an agreement under sec 22(A) of the Police Act 1996 that will allow the following;
  - an Authorising Officer power to grant an authorisation to interfere with property on an application made by a member of any of the five regional EM forces.
  - to authorise property interference likewise.

- to permit Designated Persons (DP) within the authorising force to grant authorisations for officers within any of the regional EM forces to obtain communications data
- to permit a DP to issue a notice under RIPA requiring the disclosure of communications data to an appropriate person in any of the regional EM forces.
- to permit a DP for the purposes of Directed Surveillance or CHIS activity to grant an authorisation upon application by a member of any of the regional EM forces.
- to permit a Senior Authorising Officer for the purposes of intrusive surveillance to grant an authorisation upon application by a member of any of the regional EM forces.
- 3. The Section 22 Agreement is attached in Part 2 of this agreement.
