#### **EXECUTIVE SUMMARY AND PURPOSE OF REPORT**

National funding was provided in 2013/14 and made available in 2014/15 to the East Midlands Regional PCCs, to purchase an additional discreet building within the region for relocation of existing 5 force collaborative resources. This enables co-location with the National Crime Agency, in line with the national and regional strategy and is a natural extension of a joint approach to crime collaboration in the East Midlands.
