### **EXECUTIVE SUMMARY AND PURPOSE OF REPORT**

This request relates to the provision of one off funding to enable research to support the Policing Transformation Programme to take place, as this will be required across financial years it is proposed that any balance of funding be treated as an earmarked reserve at the year end.

Whilst provision has been made for the human resources to support the Programme and there is a mechanism in place to apply for funding of specific trials and projects (through the Performance and Productivity Reserve), no separate provision has been made for the purchase (or accounting) of low cost items, such as printing, facilitating public workshops etc. The potential consequence of this is that the PCC will receive a high number of requests for decisions on funding for small amounts and a disproportional level of bureaucracy could exist which would stifle the innovation required to make the Programme a success.

	That funding of £30,000 be allocated for use by the force in research and development relating to the

## A. NON-CONFIDENTIAL FACTS AND ADVICE TO THE PCC

## A1. INTRODUCTION AND BACKGROUND

1. The Policing Transformation Programme seeks to deliver efficiency savings, particularly of our front-line officers, through various innovative developments. The

programme incorporates the whole process of change, from initial idea generation through testing to full business case and implementation.

- 2. In order to undertake research effectively the force requires some funding to support associated activities. Such activities would fall within the force element of the process as described in the PTP Monitoring Matrix document and would typically be for surveys (to gather public or internal views), to facilitate external workshops or to enable research to be carried out in other forces or agencies. Currently, the only way to access such funding is via a decision request to the Commissioner, introducing a level of bureaucracy and delay that would be disproportionate to the amount requested.
- This paper proposes that funding is allocated to the force for use in research activities to support the Policing Transformation Programme. These funds would be separately coded to enable transparency of accounting, thus enabling full oversight of spend within the Programme.
- 4. It is further proposed that the funding be initially set at £30,000. This amount will enable the force to undertake a significant amount of low cost research related activity with individual items not exceeding £5,000, with the majority being significantly lower than that. Full records of all expenditure will be retained within Strategic Development and monitored through the existing Programme governance, with accountability sitting with the Senior Responsible Officer for the Programme (myself) and quarterly review included in the PTP Development Report to the PCC.

The Policing Transformation Programme is designed to support delivery of the Police and Crime Plan and PCC's priorities to keep crime low, maintain and improve public satisfaction and confidence and to close the financial forecasted gap in 2016.

The provision of a budget for this work will enable transparency in financial reporting within the Policing Transformation Programme and to the PCC.
