05/14	<ol style="list-style-type: none"> 1) Does Lincolnshire have a wildlife crime strategy (if not are there plans to do so)? 2) Does Lincolnshire currently record wildlife crime and if so how many have there been over the past three years? 3) Does Lincolnshire currently provide wildlife crime intelligence to the National Wildlife Crime Unit (if not are there plans to do so)? 4) How many wildlife crime officers does Lincolnshire currently have, how many hours a week do they work directly on wildlife crime and are there plans to formalise this role if it hasn't been already? 5) Have you undertaken any additional activities since taking office to promote wildlife crime enforcement (please provide detail)? 	<p>Questions 1 to 4 - information not held by the Police and Crime Commissioner for Lincolnshire.</p> <p>The Police and Crime Commissioner has raised the profile of rural crime through engagement with relevant stakeholders and local communities and through attendance at key events such as the ACPO Rural Crime conference held in Cumbria and more recently the Lincolnshire Police Rural Crime Strategy meeting held on 29 May 2014. This particular event focussed on measures for tackling crime and anti-social behaviour, which significantly impacts upon rural communities in Lincolnshire. The Commissioner has also used his attendance at the annual Lincolnshire Show event to highlight wildlife crime issues. He has actively promoted the results of Force operational activity such as Operation Galileo (illegal activity by Hare coursers) and the activities of the Farm and Country Business Watch scheme. The Commissioner is a member of the National Rural Crime Network launched in February 2014 by the Rural Services Network to tackle countryside crime.</p> <p>The following is an extract from the Commissioner's Annual report for 2013/2014:</p> <p><u><i>Rural Crime</i></u></p> <p><i>I set out my commitment to focus on crime against rural communities in my</i></p>

		<p><i>Police and Crime Plan. Operation Galileo is one example of how the force has taken action to address rural crime, namely combating hare coursing incidents. Operating from September through to April, officers have worked with local farming communities to tackle the problem. Good results continue to be seen this year:</i></p> <ul style="list-style-type: none"> ●● <i>163 people have or are being prosecuted under the Hunting or Game Acts. Two years ago, there were about ten prosecutions.</i> ●● <i>97 people have been given 'words of advice' where there was insufficient evidence to prosecute.</i> ●● <i>Reported incidents have reduced to 756 (98 fewer incidents compared to last year).</i> <p><i>I've received positive feedback on the value of this rural community policing initiative from local stakeholders and will remain focussed on reducing these types of crimes.</i></p> <p><i>Other examples of good work:</i></p> <ul style="list-style-type: none"> ●● <i>Lincolnshire Police continues to work across borders to tackle rural crime, e.g. a spate of farm thefts were disrupted in October 2013 when a prolific offender was arrested in partnership with Cambridgeshire Constabulary.</i> ●● <i>Lincolnshire Police has developed partnership collaboration with the United Kingdom Border Agency and Special Branch to disrupt and prevent the exportation of stolen plant and equipment.</i>
