The Commissioner has undertaken detailed discussions with partners regarding the use of funding to support the delivery of strategic aims and community safety key priorities set out within his Police and Crime Plan. This has resulted in the following funding being allocated to services that relate in full or in part to drug or alcohol use:-</p> <p>Youth Crime and Substance Misuse - £ 60,000 Alcohol Co-ordinator - £ 55,000 DIP Funding - £120,000</p> <p style="text-align: center;">Total - £235,000</p> <p>It is not possible at this stage to advise on allocations for 2014/15. This will be considered as part of the Commissioner's budget development and planning process, which will culminate in budget proposals being presented to the Police & Crime Panel for Lincolnshire in February 2014.</p> <p>As the Commissioner is not a member of the Health and Wellbeing Board, engagement is undertaken at officer level. The Commissioner is a consultee on JSNAs and Wellbeing Strategies.</p> <p>I can confirm that a PbR mechanism is used in treatment for drugs services. Included within the performance data received by the Commissioner is the rate of offences brought to justice. We describe an offence as having been brought to justice where an offender has been cautioned, convicted, received a fixed penalty notice or a community based resolution, such as restorative justice. In addition to assessing performance against the objectives stated in the Commissioner's Police and Crime Plan, performance is also reviewed by exception, whereby significant risks and/or issues of concern are highlighted.
