SUMMARY AND PURPOSE OF REPORT		
To review the Joint Independent Audit Committee's (JIAC's) Terms of Reference, Procedure Document and Member Code of Conduct.

A. SUPPORTING INFORMATION

1. TERMS OF REFERENCE

- 1.1 The terms of reference for the Joint Independent Audit Committee (JIAC) were originally agreed on 29 November 2013. The terms of reference are reviewed by the Committee on an annual basis. A copy is attached at Appendix A.
- 1.2 An amendment is proposed under the 'Accountability Arrangements' section of the Terms of Reference to include reference to Members alternating their attendance at the Chair's meeting with the Police and Crime Commissioner and Chief Constable. Members will recall that this was amended on the Committee's Forward Plan last year.
- 1.3 Following the review of JIAC effectiveness, Members proposed an amendment to the Terms of Reference to include reference to the annual private meeting held with the Internal and External auditors. It is suggested that the 'Internal Audit' and 'External Audit' sections of the Terms of Reference be amended accordingly.

2. PROCEDURE DOCUMENT

- 2.1 The JIAC Procedure Document, which was adopted by the Committee on 25 July 2018, sets out how the Terms of Reference will be delivered. The JIAC agreed that the Procedure would be reviewed annually alongside the Terms of Reference as per the Forward Plan. A copy is attached at Appendix B.

3. CODE OF CONDUCT

- 3.1 Members of the JIAC voluntarily adopted a Code of Conduct on 27 November 2014. The Code is based on the seven principles of public life published by the Nolan Committee and prescribes a set of values, standards and behaviours to guide Member conduct. The Committee agreed to review the Code on an annual basis. A copy is attached at Appendix C.
