<p>Operation Galileo (Hare Coursing) is receiving a tremendous amount of Publicity with Helicopters, Drones and Task Forces. Isn't this a totally inappropriate use of the Police's limited funds? Is it just 'fun' and a extra overtime for the Officers involved? What % of your Budget (including Helicopter & Drone use) is being spent on this?</p>	<p>There is no requirement for the Force to capture the specific costs of Operation Galileo as part of its overall expenditure on Rural Crime. However, using the revenue budget allocated for Rural Crime for next year (2018/19) and taking the total net budget as £122.7m, the percentage this represents is 0.035%. Operation Galileo will, of course, represent a smaller percentage of that budget. Capital expenditure on Rural Crime as a percentage of the overall capital budget for 2017/18, represents approximately 1.2% of budgeted expenditure of approx. £15m.</p> <p>Helicopter charges are included within the central Helicopter budget for the Force. The use of helicopters for rural crime incidents is minimal and such call outs are not identified in the ledger.</p> <p>The drone was a capital purchase and so there is effectively no</p>

	associated cost on the revenue budget when it is used. A pool of officers are trained to use drone and whilst it will require consumable items occasionally, these are not charged to the Rural Crime budget.

<p>" is it a feature for prevention of reporting of rape , when there is financial enrichment to be gained by it not being allowed to be reported?"</p>	<p>The FOIA creates a public "right of access" to information held by public authorities, including the Office of the Police and Crime Commissioner (OPCC), and covers any information, documentation or records that are produced internally or held by that authority. I can confirm that the OPCC does not hold any information in recorded form that would be relevant to your question.</p> <p>However, as the subject matter concerns the reporting of rape, I propose to transfer your request to Lincolnshire Police as the information may be held by that organisation.</p>

For your convenience, I have provided the relevant link: https://www.blpd.gov.uk/foi/foicontractview.aspx?contractid=36423</p> <p>Your request for information at (b), (d) and (e) is refused as it is deemed commercially sensitive. In considering requests for information under the FOIA, the Office of the Police and Crime Commissioner (OPCC) may decide that the information requested is exempt from disclosure. This, in turn, may require the OPCC to apply a public interest test to ensure it is satisfied that the public interest in withholding the information is greater than the public interest in disclosing it.</p> <p>The OPCC considers that the information you have requested under (b), (d) and (e), is exempt from disclosure under Section 43</p>

of the FOIA. Section 43(2) of the Act permits the OPCC to withhold information if its disclosure would, or would be likely to, prejudice the commercial interests of any person (an individual, a company, the OPCC itself or any other legal entity). The OPCC considers that to disclose the information you have requested would prejudice the commercial interests of the parties concerned. This information is commercially sensitive to the tenderers and it is important to their competitiveness that they are able to remain as a participant in the market. With regards to our commercial interest, if the OPCC disclosed this type of information it would adversely affect our ability to source suppliers in a competitive environment.

Where the OPCC decides that the information requested is exempt from disclosure under section 43(2) of the FOIA, it must then apply what is known as a public interest test. This requires the OPCC to determine whether, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information. In applying the public interest test the OPCC has given careful consideration to the arguments for and against disclosure. When considering factors that would favour disclosing the information, the OPCC has had to assess whether disclosure of the information would:

- Allow for more informed debate on the issue;
- Promote accountability and transparency for our decisions and in our spending of public money; and
- Assist the public to understand and challenge our decisions.

Against these considerations the OPCC has to balance the likelihood of disclosure having an adverse effect on the commercial interest of the tenderers concerned and the OPCC

	<p>itself. Having taken into account the arguments for and against disclosure, the OPCC decided that the public interest in this case is best served by maintaining the exemption and by not disclosing the information requested, at this stage. The OPCC considers that the possible benefits of disclosure are outweighed by the real risk of causing prejudice to the commercial interests of the tenderers concerned and the OPCC itself. In this case there is an overriding public interest in ensuring that companies are able to compete fairly and in ensuring there is competition for OPCC contracts.</p>

This might include staff costs, legal costs, cost of market engagement events etc. Please supply the answer as total budget for the financial year 2018/19.</p>	<p>The United Nations defines violence against women as “any act of gender-based violence that results in, or is likely to result in, physical, sexual or psychological harm or suffering to women, including threats of such acts, coercion or arbitrary deprivation of liberty, whether occurring in public or in private life” (General Assembly Resolution 48/104 Declaration on the Elimination of Violence against Women, 1993). Within this definition, the use of the word ‘women’ is deemed to be inclusive of girls.</p> <p>Although we do not have a specific budget line relating to the commissioning of violence against women and girls services, the PCC has committed to funding the following services which fall within the definition in 2018/19 (see attached table).</p>

	<p>In addition, the PCC is jointly funding and hosting a Domestic Abuse Conference in November 2018 in conjunction with the Safer Lincolnshire Partnership (SLP). As this is currently in development the budget has not yet been finalised at the time of writing.</p>
<p>Please send to me information which alleges, or proves, that the U.S. Department of State and/or U.S. Department of Defence and/or any other entity committed electoral fraud at the June 8th 2017 United Kingdom general election and/or June 23rd 2016 United Kingdom European Union membership referendum.</p>	<p>Pursuant to the provisions of Section 14 of the Freedom of Information Act 2000 (the Act), I have decided to refuse your request as it has been deemed a 'Repeated Request'.</p> <p>Section 14(2) of the Act provides:</p> <p>'Where a public authority has previously complied with a request for information which was made by any person, it is not obliged to comply with a subsequent identical or substantially similar request from that person unless a reasonable interval has elapsed between compliance with the previous request and the making of the current request.'</p> <p>Our records indicate that the Office of the Police and Crime Commissioner previously complied with elements of your current request on 6 April 2018, 3 May 2018 and 10 June 2018. It is clear that a 'reasonable interval' has not elapsed between your requests.</p>
<p>A copy of your policing plan and/or information about your strategy and allocated budget and staff and other resources committed to the enforcement of the Hunting Act 2004.</p>	<p>Your request for a copy of the Police and Crime Commissioner's Policing Plan has not been provided as it is accessible to you by other means and is therefore exempt from disclosure under section 21 of the Freedom of Information Act (FOIA).
