EXECUTIVE SUMMARY AND PURPOSE OF REPORT

To approve funding to implement a standalone Niche environment for use as a Case Management System by Victim Lincs. An options paper produced by Tech Futures has been reviewed and the preferred option which provides the specified requirements for Victim Lincs is the most cost effective. This is indicatively costed at £36,055.43

To approve funding for the registration and completion of the 'Victims Choice Quality Mark' for Victim Lincs. The Quality Mark will demonstrate the service has been independently assessed and will increase public confidence in the service provided by Victim Lincs. The cost for the quality mark is £7200.00 inc VAT.

A. NON-CONFIDENTIAL FACTS AND ADVICE TO THE PCC

A1. INTRODUCTION AND BACKGROUND

- 1. Police and Crime Commissioners have responsibility for putting in place arrangements to support victims of crime. A grant is provided by the Ministry of Justice each year to fund support services, although in Lincolnshire this is combined with local community safety grants made by the Police and Crime Commissioner, domestic abuse services funded by the County Council, sexual assault referral centres commissioned jointly by NHS England and the Police and Crime Commissioner, and Rape Crisis Centres funded by the Ministry of Justice.
- 2. In 2017 the PCC commissioned the development of a new Victims' Strategy, needs assessment and new model for the delivery of victims' services. This included consultation with victims and service providers, as well as analysis of business processes, evidence and data. A key principle arising from this work was the importance of a streamlined and integrated service that supports victims throughout their journey.
- 3. This led to the in-house Victim Lincs service being established by the PCC to provide free and confidential support and guidance to anyone living, working or studying Lincolnshire affected by crime. Case officers make initial contact with victims and complete comprehensive needs assessments.
- 4. Victim Lincs require a dedicated case management system to effectively manage cases, monitor performance in line with Ministry of Justice reporting requirements and to ensure repeat victims are readily identified and supported effectively.
- 5. An independent assessment of Victim Lincs and an award of a Quality Mark will provide external assurance of the standard of service for victims of crime in Lincolnshire and will lead to increased public confidence in the service.

The implementation of the case management system and achieving the Victims Choice Quality Mark will help to deliver the strategic aims and priorities set out in one of the key principles of the Community Safety, Policing and Criminal Justice Plan for Lincolnshire 2017-2021; Protecting and supporting victims and the vulnerable.

The PCC is committed to ensuring support services can be continuously improved to meet commissioning needs.
